# **General rules**

We strive to create a safe environment for all our visitors at the event. However, we also need your help with this. Therefore, we ask you to be mindful and avoid causing damage to others, to the venue, or to the event itself. Use the provided equipment, furniture, and facilities as intended.

We are a diverse and colourful community where everyone has different boundaries, values, or worldviews. It's important to behave respectfully towards each other and accept others' decisions. Be aware that what may seem natural to you may not be so for others. When interacting with someone, always ask, especially when it involves physical contact. "No" means no, and "stop" means stop.

Always communicate clearly with others, especially if something bothers or makes you uncomfortable. If a problem arises and you feel that your signals are not being received, do not escalate the situation. Report the problem to the organizers, who will take action if necessary.

## Age limit

The minimum age for participation is 18, and we won't make an exception under any circumstances.

# Camera and photographya

It is strictly prohibited to bring any device capable of capturing images or sound onto the premises. Mobile phones and any other devices capable of image and/or sound recording must be deposited in a switched-off state at the cloakroom, such as in a bag or a zippered pocket. Although venue staff are always present, we cannot take responsibility for items deposited at the cloakroom, so only bring with you what you absolutely need.

Please note that if there is even a suspicion that you may have taken any recordings, you must immediately leave the event premises and will not be permitted to attend any future Club FurFun or other co-hosted events.

If you wish to document your attire through photography, there will be an opportunity to utilize the services of an appointed photographer at a designated location and time. This ensures that only those who have given their consent will be photographed.

### **Alcohol**

It's important to behave responsibly and to drink in moderation. If your behaviour becomes inappropriate due to alcohol consumption or if we perceive that your condition poses a risk to yourself or others, we reserve the right to remove you from the event.

### Tobacco products and smoking

You may only smoke in designated smoking areas. Similarly, the use/consumption of electronic cigarettes, heated tobacco products, and similar devices is permitted ONLY in designated smoking areas!

#### **Narcotics**

We would like to draw your attention to the fact that Hungary's drug policy is stricter than that of neighbouring countries. Apart from alcohol, there are no decriminalized psychoactive substances, so the possession and consumption of even small amounts of marijuana (or any

other prohibited substances) is punishable. Therefore, it is forbidden to bring any narcotics or psychoactive substances into the event area.

# Hiygene rules

It's important to be aware of your own health status. If you feel unwell, it's better to stay at home. Arrive at the event clean and well-groomed; a little care goes a long way!

## Data storagea

## Rules and basis of data storage and management
